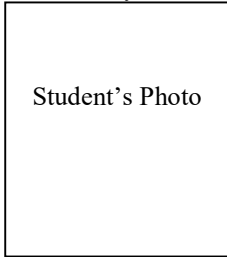
1.  - (vi) in my hostel or canteen or roaming around in the Institute while classes are in full progress.
